- 1.3 The copy must be enclosed in plain sealed envelopes marked with tender name and negotiation number and deposited in the tender box located at the reception of the Procurement office block at county headquarters along Embu – Meru highway on or before **3<sup>rd</sup> March, 2026 at 11:00 a.m.**
