- 1.1 Prices quoted should be net inclusive of all taxes and capacity building levy of 0.03 %, must be in Kenya shillings and shall remain valid for 120 days from the date of tender opening including the contract period.
- 1.2 The eligible tenderers are required to **STRICTLY** respond through e-procurement supplier's portal: www.supplier.treasury.go.ke and submit a copy of the original duly filled tender document (same as the one submitted online).
- 1.3 The copy must be enclosed in plain sealed envelopes marked with tender name and negotiation number and deposited in the tender box located at the reception of the Procurement office block at county headquarters along Embu – Meru highway on or before **20th April, 2026 at 11:00 a.m.**

There shall be mandatory Pre-Tender site visit on **15th April, 2026** at 10:30 am. All the tenderers are required avail themselves at IFAD offices Kangaru for the task.

NOTE:

One Technical Person shall represent one Bidder at the Pre-site visit.

The Individual **SHALL** bring along a hard copy of Original Introductory letter bearing the Company letterhead and an Official Stamp authorizing them to represent them in the specific pre-tender site visit/Pre-Tender Conference. The letter shall be duly signed. Photocopies or any other media shall not be accepted.

One (1) person shall only represent one (1) company per Tender.

Every bidder shall make their own arrangements to familiarize themselves with the site conditions.
