1.0 PRELIMINARY/MANDATORY REQUIREMENTS

This stage of evaluation shall involve examination of the documents and any other conditions stated in the bid document.

These conditions shall include the following:

1. Proof of Business Incorporation or Registration
2. Proof of Tax Payer Registration (PIN /VAT)
3. Proof of Tax Compliance
4. Proof of having a Local Single Business Permit.
5. Serialization of the bid document
6. Attach manufacturers authorization letter
7. Tender security of **two hundred and fifty thousand only** which shall be in **Kenya shillings** and be in form of a certified cheque, bank draft, an irrevocable letter of credit or a guarantee from a reputable Bank/ Insurance approved by **PPRA**. The format of the security shall be in accordance with the sample form included in the tender documents and the tender security shall be valid for **120 days** from the date of tender opening
8. Tenderers shall ensure that the submitted bid (documents) is (are) serialized. i.e (each page in the submitted bid shall have serial identification).

9. The tender document shall be submitted complete, intact with no page alterations

NB Any bidder who does meet the above requirement will be automatically disqualified from the technical evaluation.

The employer may seek further clarification/confirmation if necessary to confirm authenticity/compliance of any condition of the tender.

2.0 TECHNICAL REQUIREMENTS

Should be certified by commission of oaths

- (i) Duly filled Form of tender
- (ii) The bidder shall filled the attached confidential business questionnaire (S33 Form) , sign and Stamped by an individual entrusted with powers of attorney
- (iii) Attach copy of CR 12 and Identity cards for the directors
- (iv) Attach power of attorney general
- (v) Attach proof of similar supply of the same magnitude
- (vi) Audited Financial Report for the last 2 years
- (vii) Evidence of Financial Resources not less than 15% of tender sum (provide either Bank statements for the last 6 months or line of credit)
- (viii) Litigation History (provide a sworn affidavit)

Prices quoted shall be net inclusive of all taxes and must in Kenya shillings and remain valid for **120** days from the closing date of the tender.

NB: Any bidder who does meet the above requirement will be automatically disqualified from the financial evaluation.
